**RULES AND REGULATIONS**

**Early bird registration for all Livestock Exhibits is October 1<sup>st</sup> 2013. Entry Deadline is October 11, 2013. NO ENTRIES WILL BE ACCEPTED AFTER OCTOBER 11, 2013. All Livestock Shows are open to the entire state. This is an MCCA sanctioned show and a MCGJSC sanctioned show.**

**LIVESTOCK EXHIBITS**

Early bird registration for all Livestock Exhibits is **Tuesday, October 1, 2013 and will be \$5.00. Mail entries to Jones County Extension Service, P.O. Box 448, Laurel, MS 39441 on a 195 Livestock Form. Entry Deadline is October 11, 2013 with a \$15.00 entry fee. Make Checks Payable to South Mississippi Fair Commission. No late entries will be accepted after October 8, 2012.** For a complete list of show rules and regulations, contact your local County Agent's office or the Jones County Extension Service at 601-428-5201 or e-mail at jones@ext.msstate.edu.

All breeding beef cattle shall be accompanied by an Official Health Certificate showing cattle originating from an accredited Tuberculosis Free Herd or from non-quarantined herd in a Modified Accredited tuberculosis area. This health certificate must also show that the breeding cattle have been vaccinated for Brucellosis and/or are from a non-quarantined herd.

All breeding animals must be registered to show. Exception: Commercial beef. Registration papers must be in the exhibitor's name.

Showmanship awards will be given to youth in: Beef, Sheep, Swine, Goats, and Rabbits.

**RULES AND REGULATIONS**

The South Mississippi Fair reserves to itself the sole and absolute right to interpret its own rules and regulations and to determine all matters and differences in regard thereto.

1. This show is open to any 4-H and FFA member between the ages of 8-19 as of January 1. All livestock shows are open to youth in Mississippi.
2. All livestock entries must be pre-registered on Livestock Exhibit Entry form 195. **Entry forms must be submitted to the Jones County Extension Service, P. O. Box 448, Laurel, MS 39441, no later than October 11, 2013.**
3. All breeding animals competing for prizes must be registered in the exhibitors name in the recognized herd book of the breed. Original registration papers must be presented to the Superintendent when entries are checked. No premium will be paid where the names and registration numbers are not properly entered.

4. Exhibitors entered in the livestock show agree to follow the “Livestock Quality Assurance” set forth by the State 4-H Livestock Show. All steers, sheep, and commercial heifers will show in the same breed as set forth at the time of classification.
5. Blocking chutes will be allowed in designated areas only.
6. Exhibitors must inform themselves when their stock is to be judged and must be in the show ring promptly after calling of class. Animals not in the ring at show time may be ruled from competition.
7. Each exhibitor is expected to show his or her entries unassisted except when prevented by illness or because of having more than one entry in the same class. In such cases, another youth may be substituted. Show Superintendent must be informed of substitutions prior to an animal entering the arena.
8. Where there is no competition only one premium will be paid on any one animal and that premium may be 1<sup>st</sup>, 2<sup>nd</sup>, or 3<sup>rd</sup>, in accordance with the ruling of the judge. The class winner will be allowed to compete in the Championship Drive.
9. Exhibitors must be able to control their animals in the show ring at all times. Otherwise, they shall be excused from the ring in consideration of safety and fairness to themselves and other exhibitors. Animals must show reasonable amount of fitting and grooming to be eligible for prizes. Beef cattle must show at halter.
10. All bulls must be shown with a nose lead. **NO EXCEPTIONS.**
11. Exhibitors are responsible for the care and attention of their animals. Exhibitors are also responsible for maintaining the appearance of the aisle and related areas immediately adjacent to their exhibits. Failure to comply with this rule may result in revocation of premium or premiums earned.
12. Exhibitors, parents, advisors, and agents will not be allowed to have dogs in the Livestock Barns. Failure to comply may result in revocation of all premium earned.
13. Any exhibitor needing the services of a veterinarian will call the one of his choice and be responsible for such call.
14. **ALL TRAILERS WILL BE PARKED IN THE DESIGNATED PARKING AREA AT THE AIRPORT. YOU WILL BE RESPONSIBLE FOR ALL POSSESSIONS IN THE TRAILER. FAILURE TO COMPLY WITH PARKING TRAILERS AT AIRPORT WILL RESULT IN THE TOWING OF TRAILERS TO THE AIRPORT AT OWNERS EXPENSE AND THE FORFEIT OF ALL PREMIUMS.**
15. All breeding animals entering this show are required to meet the following health requirements.

**CATTLE:** Cattle originating from Mississippi will require an Official Health Certificate only. These cattle are exempt from Brucellosis and Tuberculosis tests.

**MARKET ANIMALS:** An Official Health Certificate shall accompany all market animals with each animal individually identified and be apparently free of any contagious, infectious, or communicable disease.

**SWINE:** All swine shall be accompanied by an official health certificate. All swine must be individually identified on the health certificate. Swine must originate from herds that have not had an infectious or communicable disease within the past 90 days prior to movement and this statement must be written on the health certificate.

**GOATS:** All goats shall be accompanied by an official health certificate and shall comply with the following:

- A. Originate from herds that are not quarantined for any contagious or communicable disease.
- B. Free of scabies, lice and foot rot.

### **PASS POLICY**

In an effort to more adequately serve the needs of livestock exhibitors, their parents, and sponsors, and to thoroughly clarify the position of the South Mississippi Fair Commission, the following policy relative to season passes has been adopted.

**Each livestock exhibitor will receive 1 exhibitor and 2 parent entrance passes at no charge for the day(s) he/she has animals checking in or showing. Daily Admission to the Fairgrounds is \$5.00. Special Note: (Brother/Sister or Brother/Sister joint entries will receive one exhibitor pass for each youth and one parent pass for each parent).**

**The purpose of the pass policy is that each parent will have admission to the fair for the days their child is checking in or exhibiting livestock!**

Exhibitors, parents, and sponsors agree to accept and abide by this policy by virtue of their entering livestock in the fair. Failure to comply with this policy may result in the dismissal of an individual's or group's livestock and revocation of premiums earned.

There will be no re-weighs. Steers must weigh at least 500 lbs.**

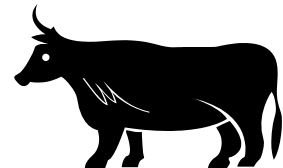

## **THIS SHOW WILL BE A MCGJSC SANCTIONED SHOW**

### **Special Rules and Regulations**

1. Follow rules and regulations as set forth by the Mississippi Livestock Directors in reference to Mississippi junior livestock shows.
2. The exhibitor must maintain continuous ownership, possession, and care of his/her goat from ownership deadline to show day. Ownership deadline is August 30, 2013.
3. All market goats and commercial does will be required to be eartagged prior to the show date, prior to weigh-in. Include MS Bred ear tag numbers of each animal. There will be a Champion & Reserve Champion MS Bred Goat. (No premium will be given; however, you will receive an award).
4. Goats will be weighed only once (no re-weighs). The minimum weight for Market Goats is 40 pounds, no maximum weight. All market goats and commercial does will be shown by weight. All Market Goats and Commercial Does will be broken into equal weight groups.
5. Market Goats may be shown that are polled, dehorned, disbudded. Removal of horns is not allowed on show grounds. Commercial Does may be horned, polled, or dehorned.
6. All Market Goats and Commercial Does are to use halters, lead chains or collars with or with a lead that is no longer than 12" in the show ring. No dog-spike or spike collar of any kind is allowed in the show ring
7. Market goats will be required to have health certificates. Any goat exhibiting an abscess or signs of any other infectious disease (sore mouth, pinkeye, ringworm, etc.) will be immediately disqualified and must be removed from the show grounds.
8. No painting, coloring, or artificial coloring is allowed.
9. Goats may be shown with hair or shorn. Goats should be clean and neat in appearance.

In addition, each division will have a champion and reserve champion MS Bred Commercial Doe and Reserve Champion Commercial Doe. No premium will be awarded for MS Bred Champion and Reserve Champion. However, an award will be given.
